You never know what sort of e-mail will arrive as a result of the RNA Web site ([www.the-rna.com](http://www.the-rna.com), just in case you haven't visited lately...)

A few weeks ago, this letter arrived in my mailbox:

*This inquiry concerns Silver Buffalo Proofs I just received today from the National Collector's Mint. Was surprised to see no denomination so I got on the net to find that these coins are not at least licensed by the US Mint.*

*Yours is the first non-ad for the National Collector's Mint search on Google so I visited your site first. Nice factual page. I am a 40 something getting back in to collecting after decades of distraction. Saw the ad for the Buffalo Proof and thought to add to my collection. I was quite surprised to be taken in so easily.*

*I genuinely thought I ordered a US Mint product. I can't remember the TV ad stating that the product was recognized currency so shame on me for not being more alert.*

*The coins are a reasonably good proof, not great, and they have serial numbers and a cert. They are dated so I can get stung by the same ad next year and if so shame on me. They are a silver clad base and the cases are covered with those hairline scratches that annoy anyone trying to enjoy a well struck coin.*

*I don't expect to get a \$200.00 coin for much less than that but would like to know if these specimens are really worth \$9.95 and will accrue value as they age.*

*If not I'm afraid I can foresee a lengthy refund process in my future.*

*Is there a market for these 2nd level proofs or can you predict one developing as more private mints churn out reproductions and commemoratives?*

Will they be worth as much as those old ride tokens for seaside heights in twenty years or are the tokens more worthy of investment?

They're really not bad proofs; just not what I thought I was ordering. Just leaving out the word 'currency' in an ad enables vendors to market something less than the real thing.

One must pay more attention to ads than ever, especially when buying coins.

I wonder how many collectors have been similarly deceived. At least when I hear "Recognized currency in the Isle of Wight" I know the coin is not what I'm looking for.

Sound familiar? We all know just what sort of ads this e-mailer has seen, right?

And even if we think we're too sophisticated to fall for the "National Collectors Mint" and its ilk, what happens to the would-be collector who gets burned by one of these ads (and, unlike this e-mailer, isn't honest enough to blame himself for making the error?)

As hobbyists, we can't do the work of law enforcement in cracking down on fraudulent offers like these – but we can fight back with education.

Any chance we have to teach our non-expert friends and acquaintances about the difference between "real" coins and these fraudulent offers is a priceless opportunity. Let's not miss it!

Drop me a line and tell me what advice you'd offer my new correspondent. I'll print some of the responses next month – and forward them to our once-burned, twice-shy would-be Buffalo owner as well.

## Ebay Buyers Beware – “There Be Weirdos in Them Hills!”

Okay, let me start off by saying that I love eBay. I collect hard times tokens, and frankly, unless I go to conventions or coin shows, there really isn't any other way to find the tokens I need (does anyone really need tokens?). I've probably dropped thousands via eBay and to date, have been extremely satisfied. In fact, I'm bidding on a few items right now.

But there is still a risk involved, and I thought RNA members might be interested to learn about an experience I recently had with an Ebay seller.

I was just about to hit the quarter century mark, and for my birthday, my dad had purchased an 1854 Type II gold dollar slabbed by SEGs as MS-61. It was a very nice coin, and the person he bought it from had a very positive feedback rating. My dad was very clear with the seller that this was a birthday present, and could we get the coin delivered by February 1<sup>st</sup>. The seller, who I'll call Mr. X, didn't think there would be a problem and was just waiting for the check to clear.

Well, about two days after the check cleared, we received the following gem of an e-mail (names are changed for reasons you'll see later!):

*I represent the estate and family of Mr. X. I regret to inform you that he was shot and killed in a robbery at his home on Jan. 23 2002. The police investigation has reached the point that I was allowed to contact customers that Mr. X had sold items to on Ebay. The estate is being inventoried and as soon as probate is completed you will receive either the item you purchased or a refund of the purchase price. The police and family are still in the process of determining what was taken in the robbery, as soon as this is complete, I will have a better idea of what can be shipped and what will be refunded. I apologize for the delay in communicating with you regarding this, but I could not notify anyone until the police authorized it. The probate and inventory should be completed in 60 - 90 days. You can help speed this up by replying to this address with the exact item you purchased, please be as descriptive as possible. If the coin was certified, please include the service and the slab # if possible. When everything is settled, I will have to try to determine who gets what and unfortunately the records are very poor. Please try to give me as*

*much identifying info as possible for the item. Please also insure that your shipping information is included and correct. Thank you for your help and cooperation in resolving this matter, there are very many customers and I try to resolve this in the most efficient manner possible.*

*Thank you.  
Mr. X's Attorney  
Attorney at Law.*

Okay, I thought this was a scam from the beginning, in part because of the lack of contact information for the “attorney,” and the numerous spelling mistakes, but we provided the information as requested in good faith. However, we got to thinking, “This should be pretty easy to confirm. We'll just go on Google.com and try and find a story about the murder, or an obituary.” Well, as I did my search, I could find no record of any murder. It wasn't impossible that there wasn't a murder, but read on.

I then did some research on the town that Mr. X came from. It was a small community of around 10,000. I found the telephone number for the local sheriff's office and left a message looking for confirmation of the murder. The sheriff's office was closed on Saturday, so I left a message asking to be contacted when they opened.

While I was doing this, other Ebay members were getting very upset. Thanks to one particular member in California, we made significant headway in learning what happened to Mr. X. By this point, about 20 ebayers had left negative feedback on Mr. X's account, and Ebay suspended active auctions that had yet to close. We, along with a bunch of other eBayers sent messages to the attorney to try and get confirmation – or even contact information. We had also sent an email indicating that we would be filing charges with the US Postal Service for mail fraud. Eventually we received the following email, which I think you'll get a kick out of:

*Coins are shipping. THIS IS NOT AN ATTEMPT TO DEFRAUD ANYONE. If you would like to file charges, go ahead and do so. Posting feedback and making threatening calls will not advance your case at all. This was a valid attempt to inform customers of what had occurred and what was being done. You and the other eBay users should be ashamed of the behavior you are exhibiting. Making calls to the family with threats is very INHUMAN of you and the others. Your coin will be shipped as soon as I can get to it. I am required to keep extensive records so the process is taking some time. Please*

*have patience, if you feel you must file an action, go ahead, but it will not get your coin shipped any faster.*

We explained to him that without confirmation of who he was, and the fact that the local sheriff had no information on a murder, and had received many phone calls from other eBayers around the country, our actions would move forward.

He responded: *I am sorry you are taking that attitude. Go ahead and file your charges and I wish you luck. It has no bearing on me. I am not providing my contact information because that is my preference. I have no desire to deal with the a\*\*holes that are so prevalent on Ebay. This mail box is filled with false claims from you great Ebay users and more than 75% are false claims. Believe or do not believe I could care less. Go ahead and file your charges.*

Well, while all this was going on, our friend in California had a close friend who was close friends with the Postmaster General. This expedited postal action – i.e., they immediately took the case. eBay was also responsive, given that the Postal Service was intimately involved at this time. Additionally, my father's staff was able to track the IP address where the “attorney” had sent his email from. Coincidentally, it was the same place that Mr. X worked! We now knew that Mr. X was indeed alive and well, and we know Mr. X was also Mr. Attorney.

Another factor that helped: the local law enforcement got on the ball and physically went to Mr. X's house and knocked on the door. It was explained to Mr. X that he had better start shipping coins, and both the sheriff and Postal Service would keep an eye on him to make sure he followed through. Well, coins miraculously started shipping! And I got my birthday present.

Unfortunately, the story doesn't end there. The coin we purchased was SLABBED, and this coin was RAW. The postal inspector on the case has asked us to submit the coin to be professionally graded. If the coin comes back under the grade Mr. X was supposed to have sent us, we will continue to pursue a conviction of mail fraud.

So, now we wait. I've sent in the coin to be graded, and it will be interesting to see what happens. This story isn't over yet, and I'll write a follow-up as soon as more information becomes available. ## **90<sup>th</sup> Anniversary Medals Are Here!**



Our club has a long tradition of special medallic issues, and our ninetieth anniversary this year is no exception.

Club member Gerry Muhl coordinated production of the RNA 90<sup>th</sup> anniversary medal, which features a design with a long history.

The original version of this medal was designed by Alphonse A. Kolb for the RNA's 700<sup>th</sup> meeting, on March 2, 1943.

Because of wartime shortages of materials, it was never issued, and exists only as a unique bronze in the club collection.

At Gerry's suggestion, the RNA chose to use a modification of this design for our 90<sup>th</sup> anniversary medal, thus completing the design process that began nearly sixty years ago.

60 examples will be struck in silver (\$12), 35 in silver-plated bronze (\$6), 35 in gold-plate bronze (\$6.50) and 35 in platinum-plated bronze (\$7.50).

A complete set of four medals is priced at \$30.
